#### The following items were agreed upon

- Bruno Manfredini has reviewed the ANP document written by Thaisa and sent it back to her to add a few references. Also, the comments and suggestions to be added on the original document sent by ANP.
- Petrobras's Debit Notes was not sent due not having their CNPJ and address. It was agreed to try to send this debit note using the main address and CNPJ given by Gioppo. Thaisa to make the Debit Note, collect Marcelo's signature and give it to Tony so he will hand it to Petrobras.
- The Budget meeting was agreed to be held at OOG on May 18<sup>th</sup> at 4pm. Gioppo requested Marcelo to bring suggestions for the meeting. Also, the agenda needs to be sent to everyone from IADC officers.
- HSE committee settled on a goal for the team; they will be working on dropped Objects to come up with a best practice guideline by the end for the year.
- Rancho das Pedras still not sending the cost breakdown for the Cook Off event on June 20<sup>th</sup>, a new location was suggested but would not be suitable for the propose of the event.
- Tony will follow up discussion about Ompetro with Aloisio. IBP is already involved. Further discussion to know if IADC will get involved or not.



- IADC's Drilling Contractors magazine will have a special edition magazine for South America. They need an interview with Gioppo generally about Brazilian Market. Tony will put Gioppo and the editor in contact so they can have the interview by email.
