Drug and Alcohol Testing in South East Asia – Guidance Note

The work on the guidance note had taken place prior to the current chairmans time in the committee. The chairman informed about a visit to ISOS with Dr. Olivier.

Chairman rased the question if we needed to include some guidance regarding the possible consequences in the various countries to the individual in case they are found guilty in drug or alcohol use.

It was agreed to approach ISOS to investigate if they had this kind of information from the various countries. Bo to take action on this.

It was also agreed that the committee would not spend much more time or effort on this paper as the Oil Producing Operators are also working on their own guideline.

Spills

Varun Ramdas opened op for a discussion about the definition of a spill.

The idea is that currently there is no guidance to follow, which makes it difficult to benchmark.

It was agreed to work on a guidance note regarding definition of spills. Varun to prepare the first draft.

Suggestions for projects

Varun suggested to look at some comon terms and conditions in contracts that we as an drilling contractor industry would oppose to.

By attempting to align across contractors we can hopefully stand a little stronger in contract negotiations, even in the tough environment we are facing currently.

It was agreed for each member to look at some common themes that we would oppose in the contract clauses from tenders. We will collect the contract clauses and “compare notes”, naturally leaving out the operators, and contractors name from any and all communication. This to be done by next meeting.
