Drug and Alcohol Testing in South East Asia – Guidance Note

From last meeting, it was agreed to approach ISOS to see if they had information related to the potential personal consequences to persons being dismissed due to the use of drug and/or alcohol.

Dr. Olivier who had been providing input to the work previously, was not available, however a second doctor at ISOS happily committed to try and gather the information. Further work on this will be halted until this is collected.

Mr. Brad Watts of Woodside had approached the chairman with some questions to the guidance note. Among other things he suggested that we include Myanmar and Korea in the document.

It was decided to look it to this.

Alex noted that a 3rd party contractor had a policy that took in to account the response from the employee when confronted with a positive test. Rather than automatic dismissal, there were other options.

It was decided to make suggestions in the guidance paper of possible reactions to a positive test result. Alex believed he would be able to provide a copy and/or detailed information on this policy.

Spills

The first draft of the Spills guidance note was presented and reviewed at the meeting.

This led to some very fruitful discussions and some specific suggestions for improvements. I'd like to thank all of the participants for their input to this, really a good effort and great collaboration all around.

A second draft will be written up and shared with the team members.



Contract clauses

The purpose of this subject is to have an open discussion about some of the HSE related contract clauses that we are seeing being entered in to the contracts.

This is to share some learnings about potential pitfalls.

A lively talk around the subject followed.

It was decided to keep this subject on the agenda, and to keep it as an open talk only.

It is very clear that we do not wish to conduct any kind of business that is in violation of IADC guidelines, or good business practice.
