He also reviewed the Anti-Trust Guidelines; wherein he emphasized the core of anti-trust law, and the required refrain from discussing pricing, dividing, allocating or boycotting suppliers or potential suppliers.

#### MRB Documentation Sub-Committee Update

- Sub Committee Chairman (Brad Green) provided an update on the subcommittee progress

- NOV has agreed to provide an example of updated MRB as per IADC recommendation

- Sub Committee Chairman (Andy Rennie) provided an update on the subcommittee progress
- Excess inventory exchange is working for some drillers. There is a standard agreement template in place for sharing excess inventory.
- Subcommittee will focus on management of rubber goods and preservation of equipment
- Chairman invited drillers to actively participate in the subcommittee.
