Minutes

Call to Order: The Chairman (Jorge Lebrija) welcomed everyone in attendance to the Supply Chain Meeting.

Safety Briefing/ Anti – Trust Guidelines/Administration

John Pertgen (IADC liaison) provided the emergency response information including muster points. He also reviewed the Anti-Trust Guidelines; wherein he emphasized the core of anti-trust law, and the required refrain from discussing pricing, dividing, allocating or boycotting suppliers or potential suppliers.

General Introductions & Agenda Review

Formal introductions were conducted. The agenda for the meeting was shared by the Chairman.

- Chairman provided overview of the committee to the new attendees.
- Details about past accomplishments of various sub-committees were explained to the broader group
- A question was asked by a new member to the chairman on whether the documents are being used only domestically or internationally as well. To this the chairman replied that the documents are being used internationally by the drillers

MRB Documentation Sub-Committee Update

- Sub Committee Chairman (Brad Green) provided an update on the subcommittee progress
- Revision 1 of document is now available on the IADC Supply Chain “Resources” [webpage](#). This was published in 2016
- It was informed by the subcommittee chairman that a major OEM (NOV) is rewriting some of its internal procedures based on drillers requirements
- The goal is to release revision 2 of the document by the end of 2018

Inventory Sub-Committee Update

International Association of Drilling Contractors

- Sub Committee Chairman (Andy Rennie) provided an update on the subcommittee's progress
- Excess inventory exchange is working well for some drillers
- Preservation of rubber goods - The goal is to publish an IADC guidance document on equipment preservation by mid-2018. A letter in this regard will be sent by the subcommittee chairman to the major OEMs soon
- It was agreed in the meeting that other initiatives including criticality identification and digital tagging will be tackled by the subcommittee only after publishing the document on preservation of rubber goods

Vendor Performance Sub-Committee Update

- Sub Committee vice-Chairman (Stephen Elliott) provided an update on the subcommittee progress
- Final updated *Metrics and Scorecard* was presented to the committee members. All the members agreed on the updated metrics. The committee is planning to publish the updated document next month
- It was agreed that the subcommittee will put together a plan to focus on the implementation and acceptance of metrics by various drilling contractors and suppliers.

Other Topics

- John Pertgen explained that the SC committee is now a Standing Committee and must follow the Endorsed Guidelines for publishing documents
- The Committee Chairman updated the group about the participation by non-drillers and how their participation will enhance the committee output
- A discussion ensued on selection of vice chairman for various sub-committees
- Workings overlaps of Inventory subcommittee of IADC Dubai chapter and IADC Houston chapter was discussed
