Minutes

Mike Killalea, IADC, opened the meeting and welcomed the participants. He then gave an update on the facility and reviewed the IADC Antitrust Policy.

Then the discussion turned to the DDR Plus / Rig Sensor project. DCS SC Co-chair Robert van Kuilenburg recommend setting aside some time to brainstorm on sensors. Mr van Kuilenburg said he had was continuing to revise rig state definitions, working from the Drilling States comparison workbook developed by John Macpherson for the DSATS Drilling States Initiative. He said he had worked through about 80% of that workbook.

The next topic was the status of the survey on the IADC Daily Drilling Report. The survey was distributed to the IADC DrillBits circulation, with more than 11,000 successfully delivered. Of those, 2,283 were opened. Further, Project Advisor John de Wardt posted an item about the survey, including URL and password on LinkedIn. At the time of the meeting, approximately 60 responses had been received. Those completing the survey were promised to be included in a drawing for a \$200 gift card.

To move the project forward, a deadline of 18 May was set for contributions. This is the day following IADC Drilling Onshore 2018, being held at the Omni Houston Hotel Westside.

Cards with the link and password to the survey will be displayed on conference tables at the event, and attendees will be urged to participate. The hope is to drive at least 200 responses from all segments of the industry. The SC seeks to receive feedback from individual drilling professionals, rather than "official" company responses, though the latter will certainly be accepted.

The survey will also be promoted in the April 2018 edition of IADC's e-letter DrillBits, the May/June edition of Drilling Contractor, LinkedIn.com, and at IADC's booth at the Offshore Technology Conference (# S-15).

Led by IADC ART DCS SC Chairman Nathan Moralez, the SC also discussed state definitions with regard to hierarchy and verification, intellectual property concerns, manual overrides of any automatically entered date, and the overall scope of the project.

The next DCS SC meeting is scheduled for 0900 on Thursday, 24 May.

There being no further business, Mr Moralez adjourned the meeting.
