Stena Presented: Rig MPD Categorization Matrix for levels of readiness for a floating drilling vessel to perform MPD operations. The matrix presented had more level dimensions than the group expected to be reasonable.

The plan is to use Stena Matrix to further define the Wood Makenzie Tier 1-4 levels. The proposed change is to separate the items from the matrix in two different groups. The first group would serve to define the tier, while the second would facilitate the categorization of the rig.
