Former top OSHA official recently met with regulators to increase fines and criminal prosecution (up to jail time) for safety violations.</p> <p>Safety Alert Discussion and Toolbox Discussion – One drilling contractor said they were- implementing digital signage on their rigs, HSE performance, safety topics and alerts, rig performance awards</p> <p>The question was raised on how do we get these in front of people to where they don't become noise? it's nice because it gives them work related things to discuss</p> <p>One company said that as an incentive to employees on the rig, HR will make job opening notifications on this system A contractor mentioned concern over radioactive sources and asked what others were doing about it. One contractor mentioned working together for safety in Norway, (as a future speaker) A contractor then mentioned that the nosedive in the workforce results in management changes which results in gap of knowledge and awareness and leadership style.</p>

900 – 930	<p>Onshore/Offshore Regulatory Updates: Christine Lederer Clyde Loll Rhett Winter John Pertgen, IADC IMO has issued new form for garbage disposal Your flag state will have to inform you of IMO changes of annex 5 – Cybersecurity – the SEC has put out interpretive guidance for companies – it will assist public companies in regard to cybersecurity (good presentation) RP 75 NOSAC is working on regulatory reform for the Coast Guard, NOSAC then divided into drilling, production, diving – the biggest recommendation from NOSAC was telling Coast Guard to withdraw NPRM on subchapter N.
