Background

- 1 The Sub-Committee, at its fifth session, agreed to establish working and drafting groups on the following subjects (SDC 5/15, paragraph 12.8):
 - .1 subdivision and damage stability;
 - .2 carriage of more than 12 industrial personnel on board vessels engaged on international voyages;
 - .3 amendments to the 2011 ESP Code; and
 - .4 safe mooring operations,

whereby the Chair, taking into account the submissions received on the respective subjects, would advise the Sub-Committee before SDC 6 on the final selection of such groups.



In addition to the aforementioned working and drafting groups, SDC 5 requested the Committee to authorize the establishment of an Experts' Group on Intact Stability (SDC 5/15, paragraph 12.9), which was approved by MSC 99 (MSC 99/22, paragraph 10.9).

Working/drafting/expert groups proposed to be established at SDC 6

- 3 After consultation with the Secretariat and bearing in mind the submissions made to the session, the Chair proposes that the following working and drafting groups be established at this session:
 - .1 Working Group on Safe Mooring Operations (agenda item 3);
 - .2 Working Group on Carriage of more than 12 Industrial Personnel on board Vessels Engaged on International Voyages (agenda item 6);
 - .3 Working Group on Subdivision and Damage Stability (agenda item 4);
 - .4 Experts Group on Second Generation Intact Stability Criteria (agenda item 5); and
 - .5 Drafting Group on Amendments to the 2011 ESP Code (agenda item 7).

Early release of working and drafting groups to start tasks

Delegations are reminded that, in accordance with the *Organization and method of work of the Maritime Safety Committee and the Marine Environment Protection Committee and their subsidiary bodies* (MSC-MEPC.1/Circ.5/Rev.1, paragraph 5.19), working and drafting groups may start work on Monday mornings based on the provisional terms of reference, pending formal discussion of those terms of reference under the relevant agenda item. It is currently intended to task the Drafting Group on Amendments to the 2011 ESP Code and the Experts Group on Second Generation Intact Stability Criteria to start their deliberations on the provisional terms of reference after consideration of agenda item 2.
