Background

- The Sub-Committee, at its fifth session, agreed to establish at this session working and drafting groups on the following subjects (SSE 5/17, paragraph 14.10):
 - .1 life-saving appliances (LSA);
 - .2 fire protection (FP);
 - .3 onboard lifting appliances and anchor handling winches (OLAW); and
 - .4 cold ironing of ships,

whereby the Chair, taking into account the submissions received on the respective subjects, would advise the Sub-Committee before SSE 6 on the final selection of such groups.

 - .2 Working Group on Fire Protection (FP) (agenda items 6, 7, 12² and 17²); and
 - .3 Working Group on Onboard Lifting Appliances and Anchor Handling Winches (OLAW) (agenda item 9).

Drafting group(s) may also be established during the session, as necessary.
