REQUEST FOR PROPOSALS -- AMENDMENT

Development of Knowledge, Skills and Abilities for Critical Drilling Positions with Well Control Responsibilities

International Association of Drilling Contractors' Department of Accreditation and Certification seeks a vendor to execute a project for development of critical competencies (technical and other safety critical competencies) for oil and gas drilling industry personnel. The project will be conducted in 3 phases: 1. Safety critical positions with emphasis on rig personnel with well control responsibilities; 2. Other rig positions with Knowledge, Skills and Abilities (KSA) currently defined by IADC; and 3. Rig-based positions for which KSAs are not currently defined by IADC.

Objectives:

- Identify critical positions with well control responsibilities
- Define critical competencies for each critical position identified
- Define KSA for each competency defined.
- Suggest optional methods for assessing each competency identified
- Provide guidance for evaluating performance
- Recommend performance measures for individual competencies
- Compare objectives and final product with similar initiatives worldwide

<u>Scope</u>: Phase 1 of the project will involve meeting above Objectives for up to 15 rig positions. Methodology is to be defined by the vendor, but suggested methods may include a combination of interviews with and compilation of donated KSA from participant companies.

Deliverables:

- Member surveys (as required)
- Worldwide review of completed and/or work in progress related projects with recommendations for utilization of templates, methodologies or best practices.
- Competencies for each position
- KSAs for each competency
- Suggested assessment methodologies
- Provide examples of Ranges of Acceptable Performance
- References
- Final comprehensive document

Estimated Time To Complete Phase 1: 6 months

Cost: Dependent upon method of execution and scope of project.

IADC Responsibilities:

- IADC to select vendor to execute project
- IADC to identify companies to participate in the project
- IADC to identify companies/personnel to be interviewed, and to send each company/personnel a letter of introduction on behalf of the 3rd party vendor company.
- IADC to provide team for review of project implementation plan, draft documents produced for Objectives 1-5, and final competencies document.
- In the event WIKI page is part of the project methodology, IADC, selected vendor or their designee will provide and maintain computer server to host the page.

Vendor Responsibilities:

- develop project implementation plan
- provide project management and technical expertise necessary to implement the project
- develop an interview guide to be consistently utilized during all interviews (as appropriate)
- develop and implement a WIKI page (if utilized) to receive participant company competency/KSA information
- conduct interviews
- compile position, competency, and KSA information solicited by interviews, WIKI page, or other means
- prepare draft competency document
- incorporate review comments into competency document
- submit final competency document in physical and electronic format
